Federal Update: ASC Updates Moved to Hospital Market Basket

In a welcome and sweeping reform of past policy, the Centers for Medicare and Medicaid Services (CMS) have finalized the 2019 ASC payment rule, moving ASCs to the hospital market basket inflation update. This establishes update parity between ASC and HOPD systems marking an end of the old policy that was leading to an ever-widening differential in the reimbursement of ASCs vs. HOPD.

Answer: Yes, changes are on the way. CMS released its 2019 Final Rule on the Payment Systems and Quality Reporting Program. CMS has established factors, such as low variance of data or high performance, to determine removal of measures from the program. This is what CMS calls "topped-out" measures. There are other factors CMS will consider in selecting a measure, such as whether the measure is applicable across different settings. For example, a measure applicable in hospital outpatient departments and outpatient surgery centers may be one CMS keeps or will consider adding.
